South African Journal of Physiotherapy (SAJP) - SASP members save R5 952.00 - R11 904.00 (Excl. Vat)

The South African Journal of Physiotherapy is the official scholarly refereed journal of the South African Society of Physiotherapy. It aims to publish original research and facilitate continuing professional development for physiotherapists and other health professionals both nationally and internationally. The journal publishes one issue each year. Articles are published online when ready for publication and then printed in an end-of-year compilation. Additional issues may be published for special events (e.g. conferences) and when special themes are addressed.

The SAJP is an open-access journal, meaning all content is freely available to users and their institutions. Users are allowed to read, download, copy, distribute, print, search, or link to the full texts of the articles, or use them for any other lawful purpose, without asking prior permission from the publisher or the author.

The SAJP has an Impact Factor of 1.2 (as of June 2025), placing it in the third quartile (Q3), indicating that it is a quality journal. It also has an h-index of 13, meaning that 13 articles in the journal have more than 13 citations.

The SAJP has a sponsorship agreement with the South African Society of Physiotherapy (SASP), with an annual limit from Society membership fees. Society members, therefore, benefit from this subsidy. The benefit is calculated in the following way:

- First author (only), being a fully paid-up SASP member at the time of submission of the manuscript and final editorial decision (after formal review) – Article Processing Charges (APCs) are supported by a once-off R11 904.00 (Excl. VAT) discount.


- Second or subsequent authors being a fully paid-up SASP member at the time of submission of the manuscript and final editorial decision (after formal review) – Article Processing Charges (APCs) are supported by a once-off R5 952.00 (Excl. VAT) discount.
- Authors who are not SASP members, APCs are not subsidised.
